Reduced reimbursements, rising costs, and the intense focus on improving clinical quality and patient satisfaction are daunting challenges. Add to that shared risk and payment reform, and running a successful facility seems impossible.

Alignment in a Risk-Sharing Landscape presents three early-adopter models that successfully improve the delivery of care so that it is more coordinated, appropriate, and cost-effective with fewer litigation risks.
