Information Exchange Nears Launch

ith the anticipated fall launch of its LANES health information exchange (HIE), the Los Angeles County Department of Health Services expects to soon begin connecting hospitals and outpatient clinics, LANES Program Director Sai Pratap said this week.

LANES, which stands for Los Angeles Network for Enhanced Services, is an electronic community-based data exchange that will allow hospitals and care providers to update, access and share medical records of Medi-Cal and uninsured patients. As a community-based entity, it is governed by the community, public and private hospitals, community clinics and health plans.

To prepare for the kickoff, HASC hosted LANES staff and planners from area hospitals at its Los Angeles headquarters on Friday, June 10.

The team is spreading the word about the system, and encouraging organizations to join by highlighting its advantages, LANES

Most Appropriate **Care Initiative Moves Forward**

The Most Appropriate Care Pilot Initiative concluded this month with 50 hospitals (representing 17 hospital systems and several stand-alone facilities) participating in one or more of the three inperson meetings or webinars. The most frequently selected topic areas were Continuous Telemetry, Palliative Care, Antibiotic Stewardship and Serial Labs.

Participation agreements were signed by 30 hospitals, indicating that the topic areas were meaningful and the initiative was valuable. By the end of the pilot, about 20 hospitals remained actively engaged.

HASC is reviewing the various options for continuing support to member hospitals who are working on Most Appropriate Care objectives. Stay tuned for more information on collaborative programming.

Board Chair Anish Mahajan, M.D., told listeners last week.

"When a patient has gone for care to multiple facilities, a doctor needs to know," Mahajan said. "(The LANES system) is user friendly — it gets the information to you quickly with just a couple of clicks."

The system will allow

participants to upload and share continuity of care documents, ADTs, transcribed notes and information on patient medications, allergies and immunizations.

The exchange will be governed by the community, public and private hospitals, community clinics and health plans. HASC's Regional VP for Los Angeles County, Jaime Garcia, serves on the LANES Board of Directors. A non-profit organization, LANES is funded by Los Angeles County, United Health Care and L.A. Care.
