### **Lifesaving Results Presented to PSF Hospitals**



Pacific Palms Resort in the City of Industry was the site of a Sept. 8 Southern California Patient Safety First meeting that related dramatic gains in managing sepsis. (Pacific Palms Resort)

Members who attended the Southern California Patient Safety First (SCPSF) Collaborative meeting at the Pacific Palms Resort in the City of Industry on Sept. 8 heard very positive news — their efforts over the past three years in better managing sepsis have saved an estimated 2,600 lives and \$50 million in associated health care costs.

"We are privileged to be leading this work in the HASC region and are so proud of all the important outcomes our hospitals are achieving," said Julia Slininger, HASC VP, Quality & Patient Safety.

Keynote presentations included both a national perspective from Dr. Timothy Hannon of Indianapolis, Ind. as well as local expertise from Dr. David Ninan of Riverside and Dr. Julie Kasarjian from Redlands. Speakers underscored additional opportunities to save lives via transfusion safety, Enhanced Recovery After Surgery (ERAS), and safe opioid prescribing. In all of this work - past, present and future — an

emphasis on reliability improves outcome replicability and sustainability. Patient safety efforts have also been aided by the expertise of our partners at the Hospital Quality Institute (HQI).

## CyberEdge Coverage Is a Timely Option

With widely-reported incidents over the past year, growing number of incicyber-security is a continuing concern for health care organizations. The findings of a May Ponemon Institute report underline the urgent and wide-ranging nature of the threat to America's health care organizations:

- 90 percent of health care organizations have experienced at least one data breach during the past two years.
- The average cost per breach is \$2.2 million.
