

'Concussion' Doctor Headlines **Annual Meeting's Speaker List**

r. Bennet Omalu, whose work documenting brain-wasting illness wife and two children. in NFL players earned attention in the 2015 film "Concussion," tops the list of speakers for HASC's 2017 Annual Meeting in Santa Barbara this April.

The meeting's theme is *Rx for Success*: *Focus on the Patient.* The event will spotlight health care's ongoing transformation from fee-for-service to population-based reimbursement.

As a county medical examiner in Pittsburgh, Pa., Omalu pushed past widespread resistance to his theory that repeated blows to the head can induce chronic traumatic encephalopathy – a dementia-like syndrome that can strike down player-veterans by their mid 50s. In 2011, he also published a paper documenting the illness in military veterans.

Omalu is chief medical examiner for San

Joaquin County. He resides in Lodi with his

Dr. Abraham Verghese, whose writing about HIV patients in rural Tennessee earned widespread notice in 1994, is an advocate for bedside medicine in an age where technology often grabs the headlines. Also on April's speaker list, he is a professor of medicine at Stanford University who has published a series of bestselling books.

Speaker Jeff Goldsmith draws on his years as a health-field educator at the University of Virginia and other institutions to peer into the future of health care. While a widely-accepted picture of the future has emerged, Goldsmith examines what might be missing, and explores missing pieces that may prove crucial for clinicians and manag-

Abbate, Long-Serving HASC VP, Passes

Anthony Abbate, who served HASC as regional vice president for Los Angeles County for many years, passed away on Oct. 4. He was 77.

Abbate put his stamp on Southern California's health care landscape over a multidecade career. Starting at City of Hope in Duarte, he went on to serve as administrator at St. Mary Medical Center in Long Beach before assuming the regional vice president role at HASC.

His legacy includes the establishment of multiple trauma centers across Southern California.

Abbate also served as a regent of the American College of Healthcare Execu-

tives and as a board member at several area hospitals including Saddleback Memorial Medical Center in Laguna Hills.

At his HASC retirement party in 2003, Abbate received a proclamation from the City of Los Angeles noting his service to the region's health care community.

A service celebrating Abbate's life is planned for 11:15 a.m. on Thursday, Oct. 13 at St. Matthew Catholic Church, 2140 W. Ontario Ave., in Corona.

Onsite Option Creates Local LEAD Academies

HASC's onsite customized academy creates a specialized version of its popular LEAD Academy to address hospitals' specific needs. With the program, facilities and systems have complete control, including the following options:

- One group or multiple groups (to help with multi-shift operations)
- Half-day sessions, fullday sessions or multiday sessions
- Which topics to deliver and in which sequence
- Rapidly completing the training, or spreading it out over weeks or months

The onsite academy is tailored to address specific areas of leadership performance that are important to individual facilities. Prior to the start of the program, program facilitator meets with senior executives to understand and identify leadership development needs. The information gathered from these discussions is used to emphasize key points in the ensuing LEAD Academy.

Participating hospitals or systems designate an onsite coordinator who handle the Karen Ochoa logistics of the academy, including room set-up and audio-visual, distributing

materials, assisting facilitators, sign-in sheets, and coordinating meals.

HASC provides the onsite coordinator with the printed session materials, personalized binders, post evaluation forms, sign-in sheets, supplemental handouts and any other information needed prior to the start of each session.
