Following two decades of service to the community, Knabe is set to retire from the Los Angeles County Board of Supervisors in December due to term-limit provisions.

## **CHPAC Support Action Needed to Attain 2016 Goal**

HASC's advocacy team is proud to report that the majority of hospitalbased California Hospital Association Political Action Committee (CHPAC) campaigns have achieved their annual goals as the end of 2016 approaches.

"If you have not already appointed a fundraising campaign coordinator, please do so and jumpstart your hospital campaign today," advised Jennifer Bayer, HASC's VP of external affairs.

The HASC region is more than halfway to its annual CHPAC fundraising goal of \$357,200 for the committee. A significant push remains to meet the goal before the Dec. 31 contribution deadline, however.

"Participation in CHPAC is critical to our advocacy efforts and works to support candidates who share our values," Bayer added.

Hospitals can reach their goals by referring hospital vendors that share likeminded values in ensuring a healthy business climate for hospitals.
