She oversees the region's upstream community health improvement strategy which seeks to maximize Kaiser's positive impact on the health of communities by leveraging all organizational assets, including and beyond coverage and care, to address social, economic, and environmental determinants of health.

Bill Sadler manages projects and internal operations at the Public Health Alliance of Southern California, a coalition of the executive leadership at ten local health departments protecting the health of nearly 60 percent of California residents. Bill assists with building the capacity of Alliance members to advance policy and systems changes on population health, prevention, health equity, social determinants of health, and built environment issues.

David Zuckerman joined The Democracy Collaborative team in 2012, and serves as director for health care engagement. He coordinates the Healthcare Anchor Network — a health-system-led collaboration focused on improving community health and well-being by building inclusive and sustainable local economies.
