# CalOptima Board Considers Support to Expand Health Care Infrastructure

The CalOptima Board of Directors received an informational presentation from its staff last week on potential uses for \$12.7 million that may be coming to the agency through an Intergovernmental Transfer (IGT) with the University of California, Irvine Medical Center, assuming the IGT is approved by CMS.

Staff indicated that six potential initiatives could be funded with the funds: a 24/7 call center, urgent care centers, expanded health information technology, the development of patient-centered medical homes, expanded access to specialty care referrals, and care management. Overall objectives are to create more of a system of care throughout Orange County, to expand the availability of care in appropriate settings. Staff indicated they will return in February with an action item to direct these funds, if forthcoming, for these projects. Responding to staff's presentation, Supervisor Janet Nguyen and other Board Members sought clarity as to who specifically would manage the funds and the projects, and asked staff to ensure

that accountability, anticipated outcomes, and results measurement are included in the recommendation coming back in February for the Board's approval.

HASC member hospitals voted last month to support the use of the funding for projects that would expand health care infrastructure in the community. A formal HASC position is anticipated based on the member vote once the proposed February Board action is available.

#### Feb. 29 Palliative Care Conference Will Focus on Care Transitions

HASC's 4th Annual Palliative Care Conference, set for Feb. 29 at Quiet Cannon Conference and Event Center, Montebello, will focus on care transitions and feature key figures in palliative care program development and operations as well as post-acute care outreach.

Sessions from the event will demonstrate how each piece of this movement is growing, leading to

significant cost reduction and improved quality of care and quality of life for patients, families and communities.

End-of-life care and the various options for patients with chronic, lifethreatening diseases are becoming a centerpiece of health care reform discussions. As more hospitals develop their in-house palliative care programs, this national initiative has

moved to post-acute care settings using integrated delivery system models across the continuum of care.

Track I will feature a national faculty of experts with case studies from hospital programs. Track 2 will focus on post-acute continuum of care, highlighting the power and effectiveness of palliative care and hospice care.

## ACHE Leadership Conference to Feature HASC/Blue Cross Collaboration

George Mack, HASC vice president, Payer & Provider Relations, is scheduled to appear March 20 at American College of Healthcare Executive's 2012 Congress on Healthcare Leadership. His seminar, Blue Ocean Thinking through Collaborative Process Performance Improvement, will examine the innovative partnership between HASC and Blue Cross of California that has successfully unmasked waste, improved inefficient workflows and eliminated unnecessary re-work.

Kenny Deng, senior director, Provider Services & Operations for Blue Cross of California, and Dan Martinez, director of Patient Financial Services at Mission Hospital, SJHS-Orange, will be co-presenters.

The HASC/Blue Cross of California collaboration began in 2009 as a work group made up of HASC member contracting and revenue cycle cohorts, and Blue Shield of California senior executives, with the goal of improving the current claims adjudication process for faster payments to hospitals, and reducing expenses for both hospitals and health plans. The work group has recently expanded to

include case managers, UM cohorts and Blue Shield medical directors responsible for the health plan's medical review processes as it seeks opportunities to improve clinical denial rates.
