HASC Holds Readmissions Reduction Collaborative Kickoff Meeting

HASC's Readmissions Reduction Collaborative (RRC) held its kickoff session June 1 and 2 at the L.A. Area Chamber of Commerce in downtown Los Angeles. Thirty participants from seven area hospitals attended the two-day session, which included a focus on health care reform and the business case for preventing hospital readmissions, as well as interactive sessions to help hospitals evaluate their current discharge processes, discuss resources and barriers, and design initial action plans.

This Collaborative work is funded by a grant from L.A. Care Health Plan for hospitals with whom they contract for acute care services. Experts serving on the Collaborative include several

physicians from the Society for Hospital Medicine, who bring national expertise in implementing the BOOST (Better Outcomes for Older adults through Safer Transitions) initiative and toolkit all over the United States.

While strategies and tools to improve the initial post-acute phase of a patient care episode will benefit all patients, certain patients--particularly those who are elderly, have chronic conditions and/or who take multiple medications--are at a greater risk for readmission. The BOOST strategies and tools are aimed at addressing the special needs of these patients during the acute hospitalization phase, and improving planning and follow-through for the subsequent weeks.

HASC's RRC is unique compared to other BOOST Collaboratives across the country in that it will add another dimension to the teamwork. Each participant hospital will engage a facility in the post-acute setting, such as a nursing home or home health agency, to reach across the continuum of care to improve the handoff for patients at highest risk of medical error or readmission. The goal is to gain shared knowledge about accountability for and coordination of the post-acute care episode, as the Collaborative focuses on patient-centered care during this year-long process.

- July 22 In-depth overview of

the Improve Phase of Lean. • July 29 - Introduction to the Control Phase of Lean.

Designed for health care professionals, this five-session workshop provides a comprehensive introduction to Lean methods and tools proven to eliminate waste, reduce costs, improve quality, and deliver greater value to organizations. Each session incorporates real-world simulations and exercises. Qualified participants may enroll for the Lean Practitioners Certification Exam at

UCLA Extension to become a Certified Lean Practitioner after completing the course.
