### Blue Shield of California ACO Provider Grant Application Deadline Aug. 1

Blue Shield of California, a nonprofit commercial health plan, announced on June 7 the return of \$180 million in subscriber premiums, a cap of its net revenue at 2 percent, and \$10 million in grants for providers throughout California. This marks a new approach taken by a health plan to address public criticism of rising premiums and overall health care costs.

The grants are aimed at hospitals and physician groups committed to developing new ways to coordinate care through Accountable Care Organizations (ACOs). Grants will be paid in a lump sum or in installments (for example, 50 percent immediately upon award, and 50 percent upon the completion of an appropriate milestone). Grants may also be made in the form of matching funds (for example, for every dollar the grantee invests in its proposed project(s), Blue Shield of California will match it with a grant of up to three dollars).

Completed grant applications must be received by Blue Shield no later than Aug. 1, 2011. Based on the number of submissions, decisions could be announced by Sept. 30, 2011.

### Inland Empire to Launch Coverage Expansion Program for Low Income Residents

The Insure the Uninsured Project (IUP) held meetings in Riverside and San Bernardino counties recently to share information on the 1115 Waiver and the current plans to expand coverage to uninsured Californians who are at or under federal poverty level (FPL) of 200 percent. Both regions will be impacted.

HASC represents the needs and concerns of Inland Area hospitals at these meetings, and works collaboratively with the counties toward implementing 1115 Waiver and other aspects of the Affordable Care Act.

California's uninsured jumped to 7.1 million in 2009. The Inland Empire is among the areas that report higher than average rates of residents without coverage. In Riverside, 25 percent of residents are uninsured, and in San Bernardino, the number is nearly 30 percent.

The low income health program (LIHP), part of the 1115 Waiver package that will act as a bridge to health care reform, provides coverage for medically indigent adults. While some details for the program are to be determined, goals include building network capacity while enrolling eligible populations; providing highquality, coordinated care to bend the cost curve; and ultimately easing the transition to 2014 requirements.

To participate, a resident must be:

- Adult age 19-64
- Currently uninsured
