Los Angeles County to Receive Grant Funds for Emergency Preparedness

The Los Angeles County Board of Supervisors voted to accept the County's allocation of the 2010 Urban Area Security Initiative (UASI) Grant from the Department of Homeland Security. The UASI Grant enhances the capacity of state and local agencies to respond to incidents of terrorism and natural disasters through coordinated training, exercises, equipment acquisition and technical assistance.

The local grant award is administered for the Los Angeles/Long Beach Urban Area by the City of

Los Angeles. The Los Angeles/Long Beach Urban Area, which includes the County, the cities of Los Angeles and Long Beach as well as 26 other participating jurisdictions, received \$69,922,146. The County's portion of the 2010 award is \$8,949,330 to be distributed as follows:

- Chief Executive Office/Office of Emergency Management -\$590,000
- Health Services \$638,888 (Gurney Purchase Reimbursement to Private and Public Hospitals)
- Fire \$1,284,694 (the department

has already included all but \$250,000 of its portion of the grant award in its FY 2011-2012 adopted budget)

- Public Health \$170,000
- Sheriff \$6,205,748
- Mental Health \$60,000 The California Emergency Management Agency has provided the Los Angeles County Operational Area with specific guidelines for the administration, management and utilization of the UASI Grant.

No FOHC for FundingInland Empire

The Health Resources and Services Administration (HRSA) awarded a total of 67 Community Health Center New Access Point grants nationwide out of 800 requests received. The Inland Empire, which had applied for this funding, did not receive any of the grant money for health care services in the region.

According to HRSA, the applica-

tions funded were primarily in rural areas and serving special populations, such as homeless patients.

The lack of Federally Qualified Health Center funding in the region places both Riverside and San Bernardino counties on precarious footing in terms of the region's health care system, said Christina Bivona-Tellez, HASC Inland Area regional vice president. "This setback will not deter the region's efforts to pursue additional FQHCs for our area. We are currently very under equity in the number of FQHCs to population, with only 10 FQHCs for a population base of almost 4 million."

Volunteers Needed for CareNow, Inc. Metropolitan Free Clinic Oct. 20-23

Hospital volunteers are being sought for CareNow, Inc.'s free clinic, scheduled to take place Oct. 20-23 at the Los Angeles Sports Arena. In addition to physician and nurse volunteers, the organization is looking for help in the following areas:

 For the past two years, three free

clinics have been conducted in greater Los Angeles to provide medical, dental and vision services to thousands of patients over the period of one week. The first two were produced in association with Remote Area Medical (RAM) and the third with Maria Shriver's Women's Conference. The local organizers of these events have formed CareNow, Inc., a new local 501(c)(3) non-profit, to continue producing these events in Los Angeles.

Approximately 5,000 patients are expected to be treated at

CareNow's upcoming free clinic. Follow-up care will be provided to patients who need it. The event can help to reduce the number of patients utilizing ERs for primary care.
