OC Board of Supervisors Slashes Hospital Funding for Indigent Care

Reacting to the loss of nearly \$50 million at the hands of the state, the Orange County Board of Supervisors approved a revised budget last Tuesday, cutting millions in planned appropriations for hospitals, public safety and others in order to obtain a balanced budget. \$3 million of \$4 million in appropriations to the MSI Hospital Pool, a portion of the \$29 million total cut from the budget, would have increased average inpatient day payments to hospitals in the County's indigent care program, MSI, a program long acknowledged to be underfunded.

Hospitals are paid, on average, 33 cents to the dollar of the actual cost of providing services in the MSI program. Exacerbating the impact of these cuts for hospitals is that County expenditures are matched, dollar for dollar, by the federal government to help counties expand access to health care. The actual loss to hospitals as a result of last week's Board of Supervisors action is therefore \$6 million.

CareNow, Inc. Metropolitan Free Clinic Still In Need of Hospital Supplies

Hospital supplies are still needed for CareNow, Inc.'s upcoming free clinic Oct. 20-23 at the Los Angeles Sports Arena.

A variety of medical supplies are needed, including but not limited to: gloves, hand sanitizer, alcohol preps, tongue depressors, cortisone cream, bandages, needles, syringes, table paper, disposable stethoscopes and safety glasses. For the past two years, three free clinics have been conducted in greater Los Angeles to provide medical, dental and vision services to thousands of patients. The first two were produced in association with Remote Area Medical (RAM) and the third with Maria Shriver's Women's Conference. The local organizers of these events have formed CareNow, Inc., a new local 501(c)(3) non-profit, to continue producing these events in Los Angeles.

Approximately 5,000 patients are expected to be treated at CareNow's upcoming free clinic. Follow-up care will be provided to patients who need it.

Area Hospitals Seek Exemption from AQMD Rule

The governing board of the South Coast Air Quality Management District (SCAQMD) voted almost unanimously to return a proposed amendment to the stationary source committee. The proposed amendment would require all new emergency generators to have a particulate filtration device installed, and the installation of the particulate filtration devices was a major concern to the health care sector.

At meetings regarding this issue, hospitals were defined as essential utility service providers and thus received a voluntary bypass exemption to utilize a pressure relief device to bypass the particulate filter during an emergency. This would be allowed if the particulate filtration device were to interfere (become clogged) during emergency generator operations. The bypass exemption was intended to mitigate any undue risk associated with the failure of the particulate filter, which could *Continued on page 2*
